# 124/14 Apologies for Absence

### 127/14 Minutes of Meeting held on 9 March 2015

**Resolved** that the minutes of the meeting of the Finance & General Purposes Committee held on 9 March 2015 be confirmed as a correct record & signed by the Chairman.

#### 128/14 Police Report

Inspector Gary Hunter advised that crime figures were down overall for Ewanrigg, Ellenborough, Flimby & Netherhall wards compared to the previous year's figures. A drugs raid had been carried out on a property on Ewanrigg Road, where 1.7 kilos of amphetamine had been seized. A drugs warrant had been issued for a property on Westfield Drive, Flimby.

Inspector Hunter responded to a number of questions from members:

Inspector Hunter agreed to investigate a report of dogs being trained at Flimby
Playing Field being out of control, having caused injury to a resident & his dog.
Inspector Hunter agreed to ensure that patrols kept a check on the Memorial
Gardens bus shelter, where graffiti had been added to a recently painted
shelter.
Inspector Hunter agreed to provide a letter of support from Cumbria Police for
the replacement gateway proposed at Well Lane, Maryport, (Planning &
Development Committee minute 100/14 refers).

**Resolved** that the report be noted & that Cumbria Police be thanked for their hard work.

## 129/14 Correspondence

**Resolved** that the schedule of correspondence be received & noted, & the following matters determined:

- That a grant of £250 be awarded to Netherhall School to contribute towards funding for a course delivered by Stonewall in support of the school's project to combat bullying.
- 2) That a grant of £200 be awarded to Netherhall Football Club to cover the costs of bus hire, referee costs & laundry hire for the club competing in the County Cup final.
- 3) That a grant of £250 be awarded to Demi Fisher to support costs of her selection for the England Students Rugby League squad, recognising the prestige that such an appointment brings to the area.
- 4) That an increase of 2.5% in the cost of ground maintenance carried out by ISS Facility Services at Ellenborough Playing Field, with effect from April 2015, be agreed.
- 5) That Allerdale Borough Council be advised that the Town Council does not wish to take up its offer to supply dog waste bags for distribution.
- 6) That the Town Council not undertake any celebratory events concerning the 70<sup>th</sup> anniversary of VE Day over the weekend 8 to 10 May 2015.
- 7) That, following a request received for the provision of a BMX track from Mr J Ackerley, he be advised that the Council supported his request & that arrangements were being put in place for such a facility through the Ewanrigg Local Trust, whom it be suggested he contact.
- 8) That, following receipt of proposals for development of the harbour area, Mr D Scott of Edinburgh, (a regular visitor), be informed that proposals for a Tidal Lagoon being developed for the area would appear to meet his aspirations.
- 9) That, following a request for support in the refurbishment of a trawler from Dr C Platt, the Council advise that whilst it appreciates his enthusiasm, it has no resources for such a project & is unclear on how the trawler would be sustained.
- 10) That a grant of £250 be awarded to Glassonbury Committee for its annual charity music festival, & that the committee be advised of Council grant funding arrangements for the following year & of Allerdale BOROUGH Council funding availability for festivals.
- 11) That a grant of £250 be awarded to Our Lady & St Patricks School towards its gardening project, & that the school be advised of possible funding through Cumbria County Council.
- 12) That a grant of £250 be awarded to Maryport Extended Schools' Partnership towards its Trail Maps development project.
