- 1) Further to a request from Mr Reay of Buttermere Road, Maryport, for a joint tenancy arrangement on his plot at Sandy Lonning Allotment Site, no joint tenancy be agreed & the current arrangement continue until the cessation of the tenancy.

- 2) Further to a request from Mr B Taylor of Coronation Street, Maryport, for compensation from the Town Council in respect of losses incurred on his plot at Sandy Lonning Allotment Site as a result of flooding, no compensation from the Town Council be agreed, & that it be suggested to Mr Taylor that he consider approaching the Cumbria Community Foundation in respect of his losses due to flooding
- 3) Further to a request from Mr Clague of Sandy Lonning to swap his plot on Sandy Lonning Allotment Site with another on that site, due to difficulties experienced accessing his current plot because of his disability, it be agreed that the Council assist Mr Clague where possible.
- 4) Further to a request from Mr Mason of Brook Street, Flimby, to swap his plot, due to his current plot being prone to flooding, it be agreed that the Council accommodate Mr Mason where possible in finding a new plot.
- 5) Further to a letter from Mr Saunders of the Flimby Allotment Committee concerning the vehicle height restrictor in place at the Flimby Allotment Site entrance, the response provided to Mr Saunders be endorsed.
