105/14 Apologies for Absence

- 2) That the response from the Department for Work & Pensions concerning poverty be noted & disappointment expressed at the apparent failure to understand the adverse impact which some of the government's policies were having on those suffering from poverty in the community.
- 3) That Maryport Harbour & Marina Ltd's request for the lease of the land on which Shiver Me Timbers Play Area was situated to be extended for a further twelve months until 31 March 2016, & that the Council welcome the thanks received for continued support, noting that it was the only council which continued to offer financial support to the company.
- 4) That Tidal Lagoon Power be invited to meet with the Council to discuss its plans for a Tidal Lagoon development in West Cumbria, & that Seaton Parish Council members be invited to attend.
