A "sensitive interest" is an interest which could result in, or is likely to result in a serious risk that you, or a person connected with you, may be subjected to violence of intimidation. Sensitive Interests Where you consider that this may apply to you, you should consult the Monitoring Officer. Subject to their agreement, you may not need to include that interest on this form. However, when the interest is no longer considered to be a "sensitive interest" you must notify the Monitoring Officer within 28 days of that change.

A Member must, within 28 days of becoming aware of any new personal interest or change to any personal interest specified above, register details of that new personal interest or Note: change by providing written notification to the Council's Monitoring Officer.

- (d) Participate, or participate further, in any discussion or vote on a matter which you have a disclosable pecuniary interest unless I have a dispensation or members of the public are also allowed to speak and have spoken I will leave the meeting.
- (e) Knowingly provide information that is false, misleading or reckless.

## Disclosable pecuniary interests

A disclosable pecuniary interest is an interest which:

- Is of a description specified in regulations made by the Secretary of State; and
- Either it is your interest, or an interest of your partner (which means spouse or civil
  partner, a person with whom you are living as husband or wife, or a person with whom
  you are living as if you are civil partners).

You must register your disclosable pecuniary interests and those of your partner.

In this notification 'relevant authority' means NAME Parish Council.
