126/23 Apologies for Absence

Apologies for absence were received from Councillors C Bell, P Hetherington, G Kemp, J Newton & W Pegram.

127/23 Declarations of Interest

Declarations of interest were received from Councillor I Greaney, Item 7(1), Personal as a Governor of Grasslot School & Councillor G Mitchell, Item 7(2), Personal as a contractor to Netherton Infant School.

129/23 Minutes of Meeting held on 26 February 2024

Resolved that the minutes of the meeting held on 26 February 2024 be agreed & signed by the Chairman as a correct record.

130/23 Public Participation

No questions received.

131/23 Presentation from Cumberland Council Officer Paul Shearsby

A presentation was received from Cumberland Council Neighbourhoods Interim Education & Enforcement Lead Manager Paul Shearsby on how Cumberland Council was dealing with the ongoing problem with dog fouling in the Maryport area. He advised that a new policy was being developed based on a zero-tolerance approach, with on-the-spot fines issued for those transgressing. A campaign was currently being conducted in the Maryport area, involving twelve enforcement officers, which to date had resulted in two dog owners receiving a court summons & some eighty people spoken to. Mr Shearsby was investigating the introduction of dog-on-lead & dog exclusion areas, together with a camera system for identifying culprits. Signage was being developed which would be displayed at appropriate sites. It was proposed that details of perpetrators would be publicised. Members asked a number of questions & Mr Shearsby advised that:

- He considered that the roles of Environmental Enforcement & Traffic Warden could not be combined, since a trial in Carlisle had not proved successful
- The introduction of new arrangements would receive wide publicity
- Cumberland Council would base the denomination of dog control areas on official complaints received from the public
- Schools would be involved in promoting the scheme

Resolved that Mr Shearsby be thanked for his report.

132/23 Correspondence

Resolved that the schedule of correspondence be received & noted, & that:

- 1) Grasslot School be awarded a grant of £1,000 towards the development of a cross-school science project.
- 2) Consideration of an application for funding from the Maryport Education Group be deferred pending the receipt of further information, including details of how the proposed project on pollution in oceans & on beaches would operate, the overall cost of the proposed scheme & a breakdown of the budget.
- 3) Further to Minute 122/23 & following the receipt of further information, it be agreed to provide further funding of £2,700 towards the Taste of the Sea Festival operated by Cumberland Council, making a total contribution of £20,000 from the Town Council.
